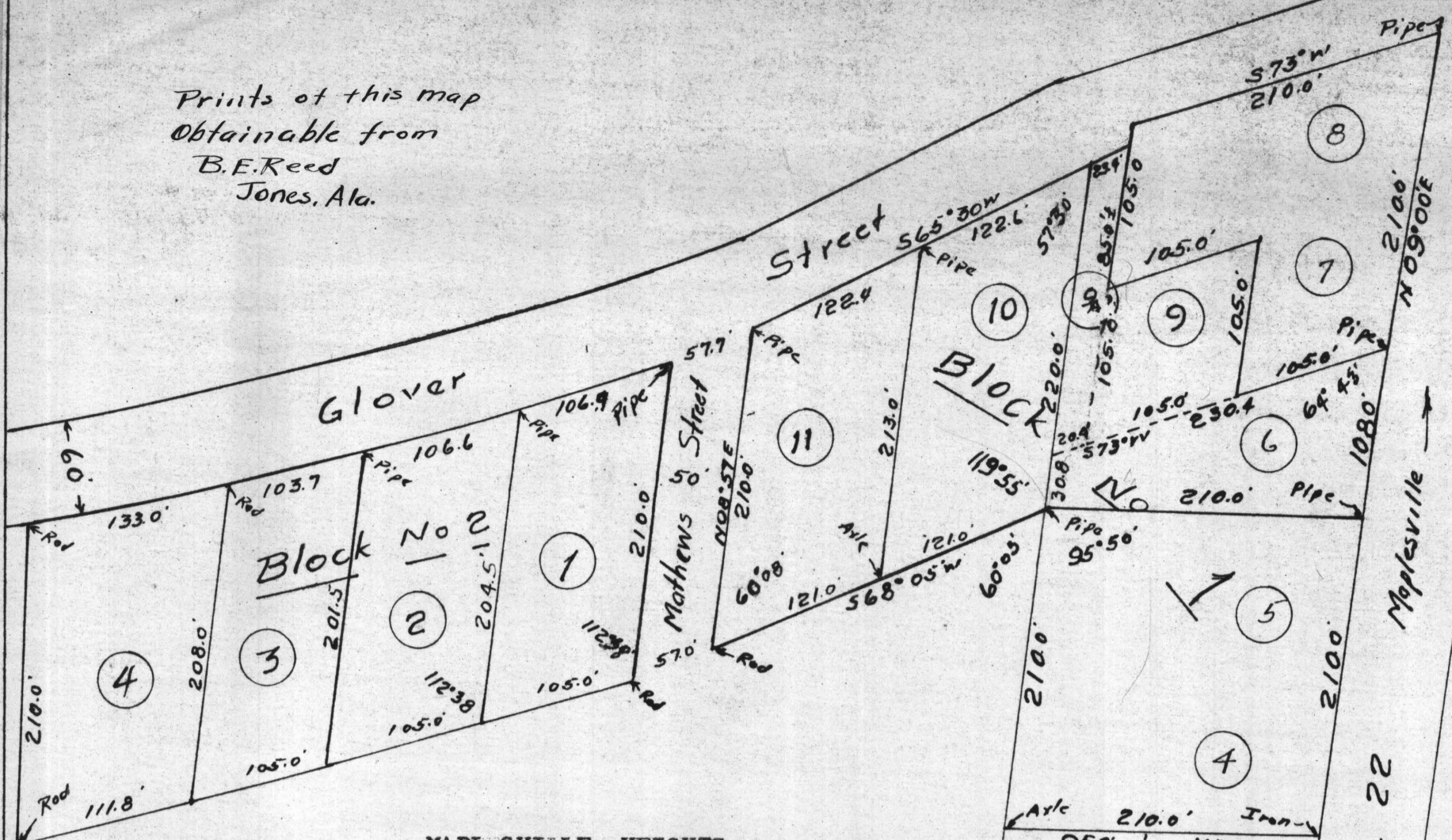

Glover Estate and laying in the East half of the Southwest quarter of section 21 T. 21 N., R. 12 E, with GLOVER'S KORNERS subdivision superimposed to show the extensions of the lots of Glover's Korners extended Westerly to a total depth of 210.00 feet or slightly greater depth. 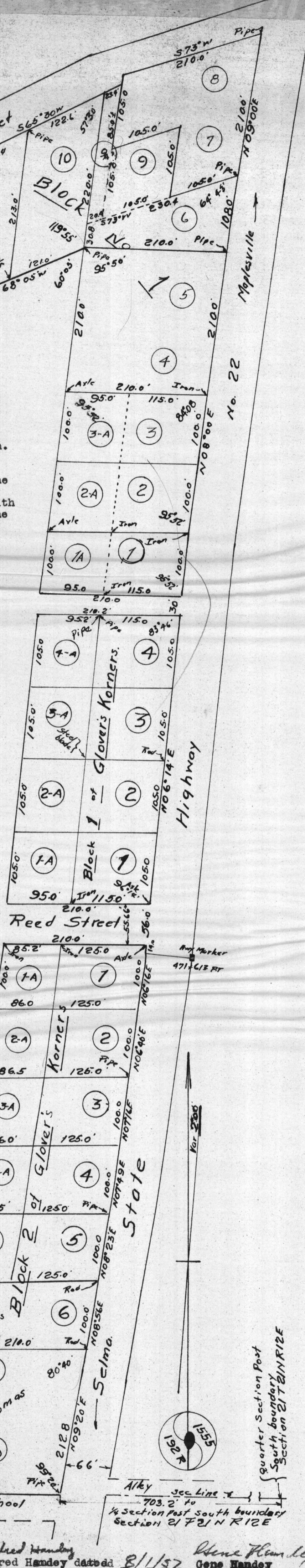
