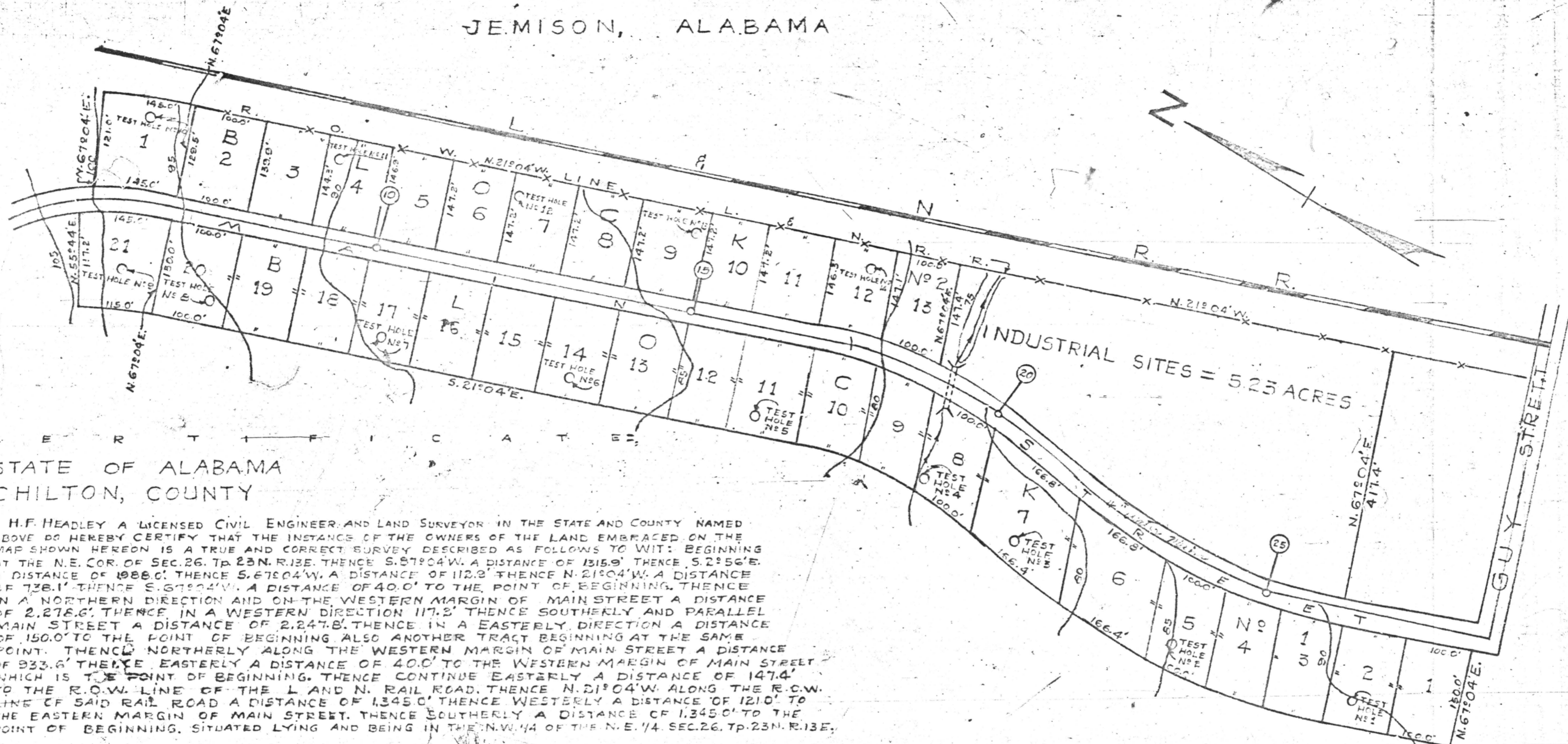


RECORD MAP

COR. OF SEC. 26, T. 23N. R. 13E. THENCE S. 87° 04' W. A DISTANCE OF 1315.9' THENCE S. 2° 56' E. A DISTANCE OF 1988.0' THENCE S. 67° 04' W. A DISTANCE OF 112.3' THENCE N. 21° 04' W. A DISTANCE OF 738.1' THENCE S. 67° 04' W. A DISTANCE OF 40.0' TO THE POINT OF BEGINNING. THENCE IN A NORTHERN DIRECTION AND ON THE WESTERN MARGIN OF MAIN STREET A DISTANCE OF 2,278.6' THENCE IN A WESTERN DIRECTION 117.2' THENCE SOUTHERLY AND PARALLEL MAIN STREET A DISTANCE OF 2,247.8' THENCE IN A EASTERLY DIRECTION A DISTANCE OF 150.0' TO THE POINT OF BEGINNING ALSO ANOTHER TRACT BEGINNING AT THE SAME POINT. THENCE NORTHERLY ALONG THE WESTERN MARGIN OF MAIN STREET A DISTANCE OF 933.6' THENCE EASTERLY A DISTANCE OF 40.0' TO THE WESTERN MARGIN OF MAIN STREET WHICH IS THE POINT OF BEGINNING. THENCE CONTINUE EASTERLY A DISTANCE OF 147.4' TO THE R.O.W. LINE OF THE L AND N. RAIL ROAD. THENCE N. 21° 04' W. ALONG THE R.O.W. LINE OF SAID RAIL ROAD A DISTANCE OF 1,345.0' THENCE WESTERLY A DISTANCE OF 121.0' TO THE EASTERN MARGIN OF MAIN STREET. THENCE SOUTHERLY A DISTANCE OF 1,345.0' TO THE POINT OF BEGINNING.
