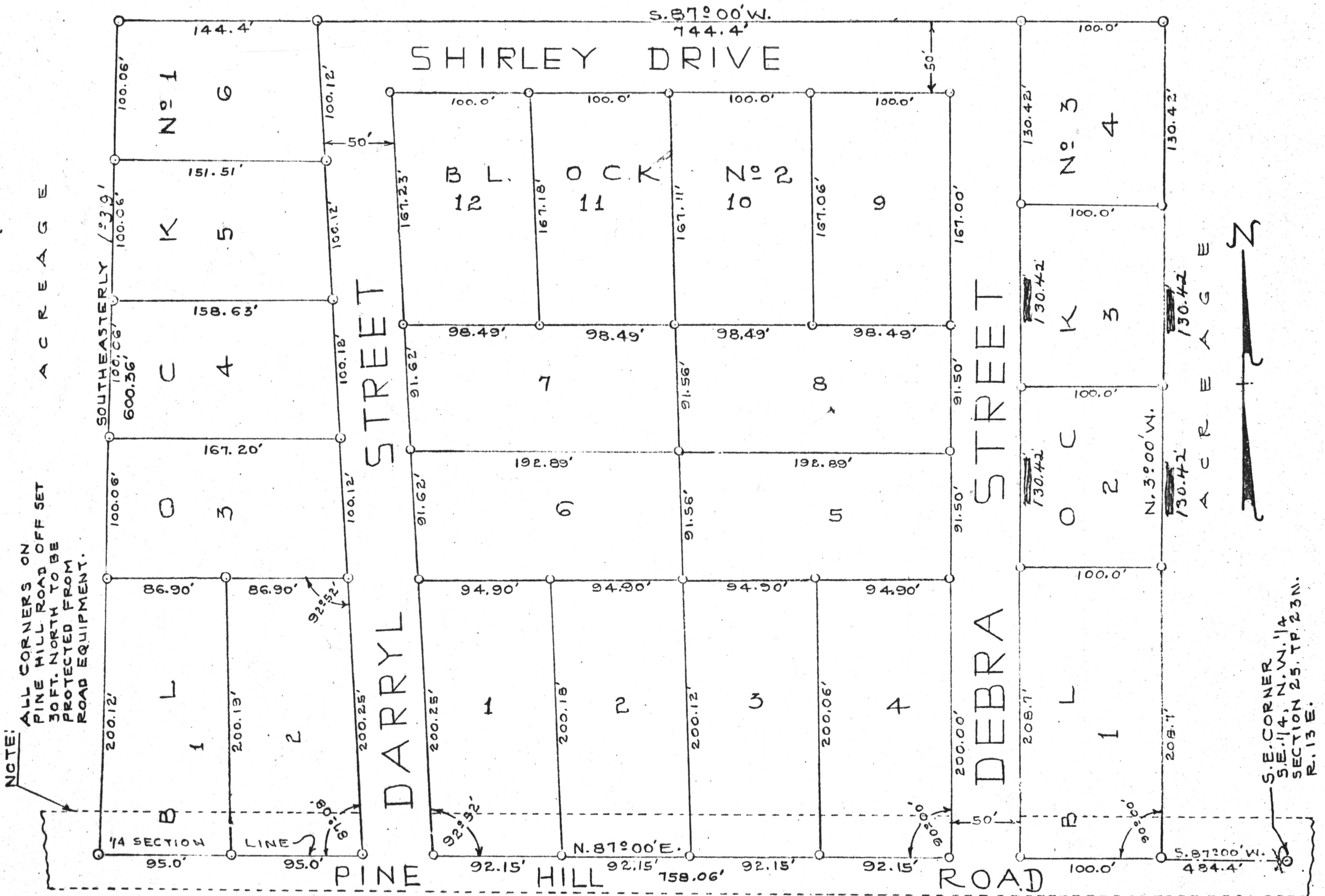

CORNER OF THE S.E. 1/4, N.W. 1/4, SECTION 25, TP. 23N-R. 13E. THENCE S. 87°00'W. ALONG THE PINE HILL ROAD 484.4 FT. TO THE POINT OF BEGINNING. THENCE N. 32°00'W. 600.0', THENCE S. 87°00'W. 744.4'. THENCE SOUTHEASTERLY 600.36' TO THE 1/4 SECTION LINE AND PINE HILL ROAD; THENCE N. 87°00'E. ALONG THE PINE HILL ROAD 758.06' TO THE POINT OF BEGINNING.
