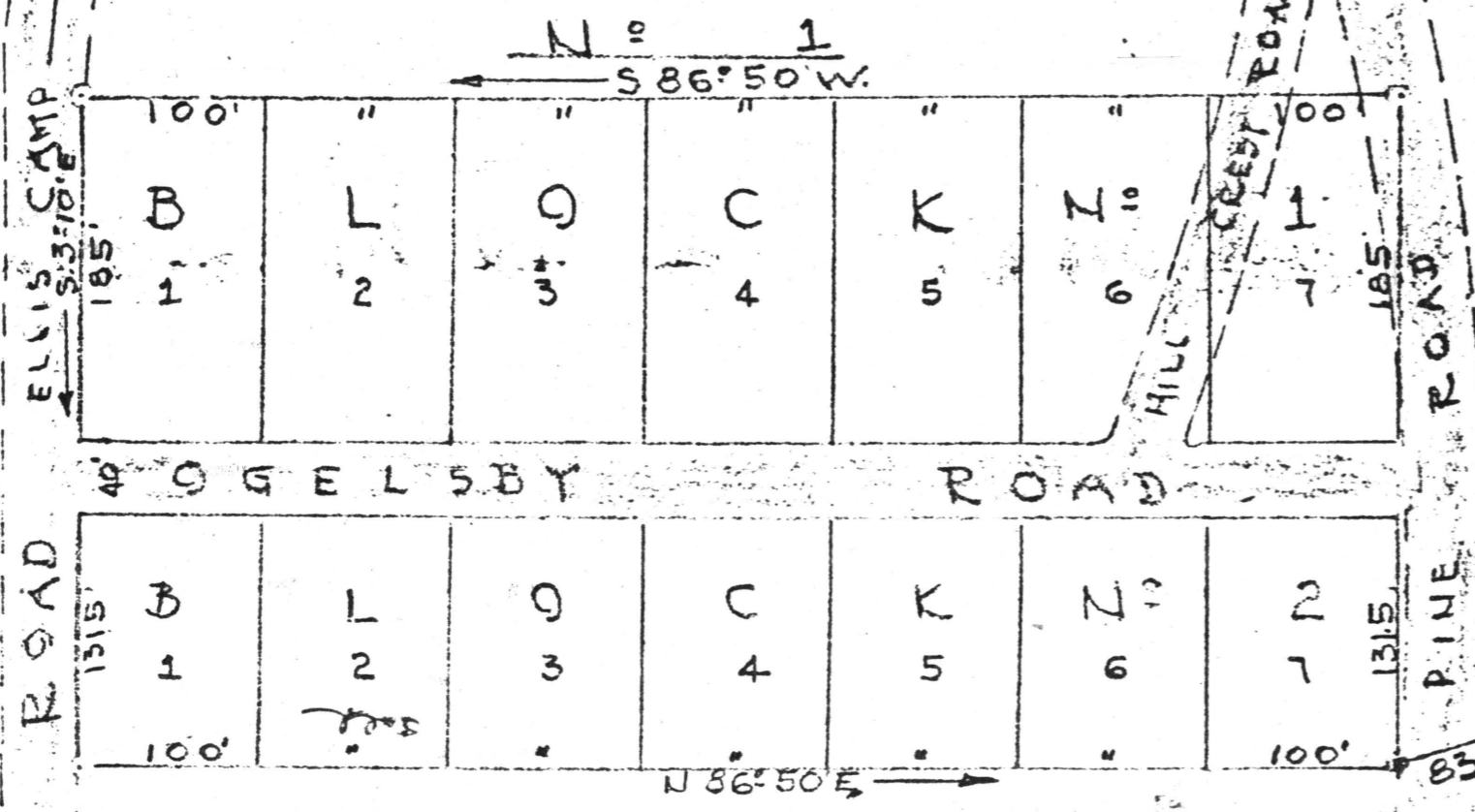


RECORD MAP OGELSBY SURVEY

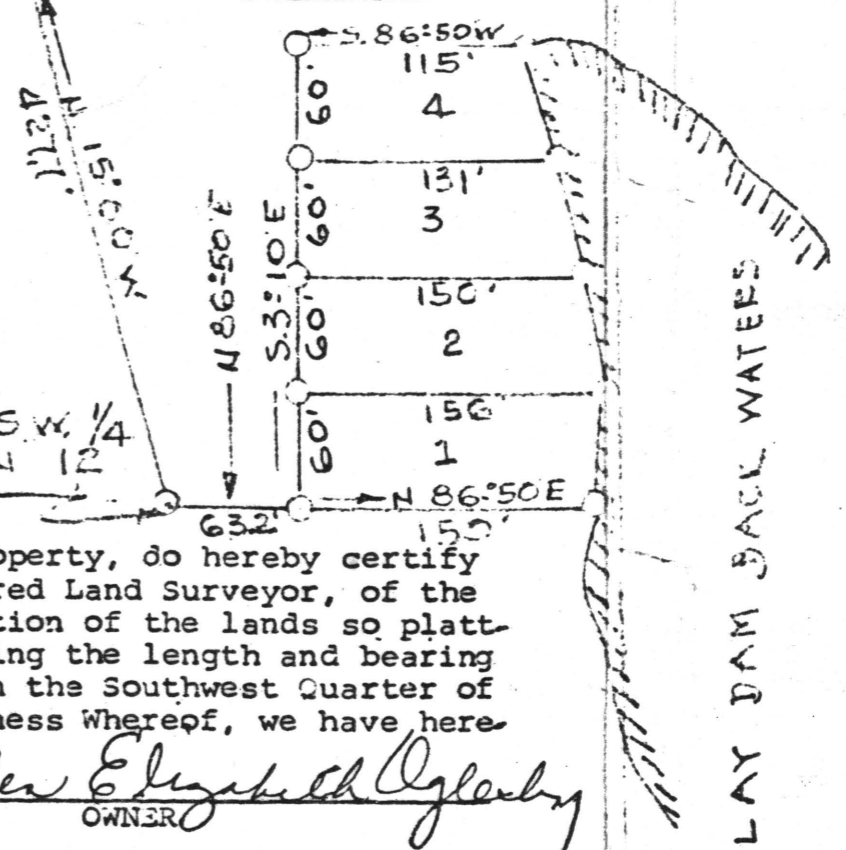

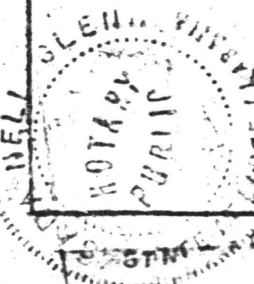
