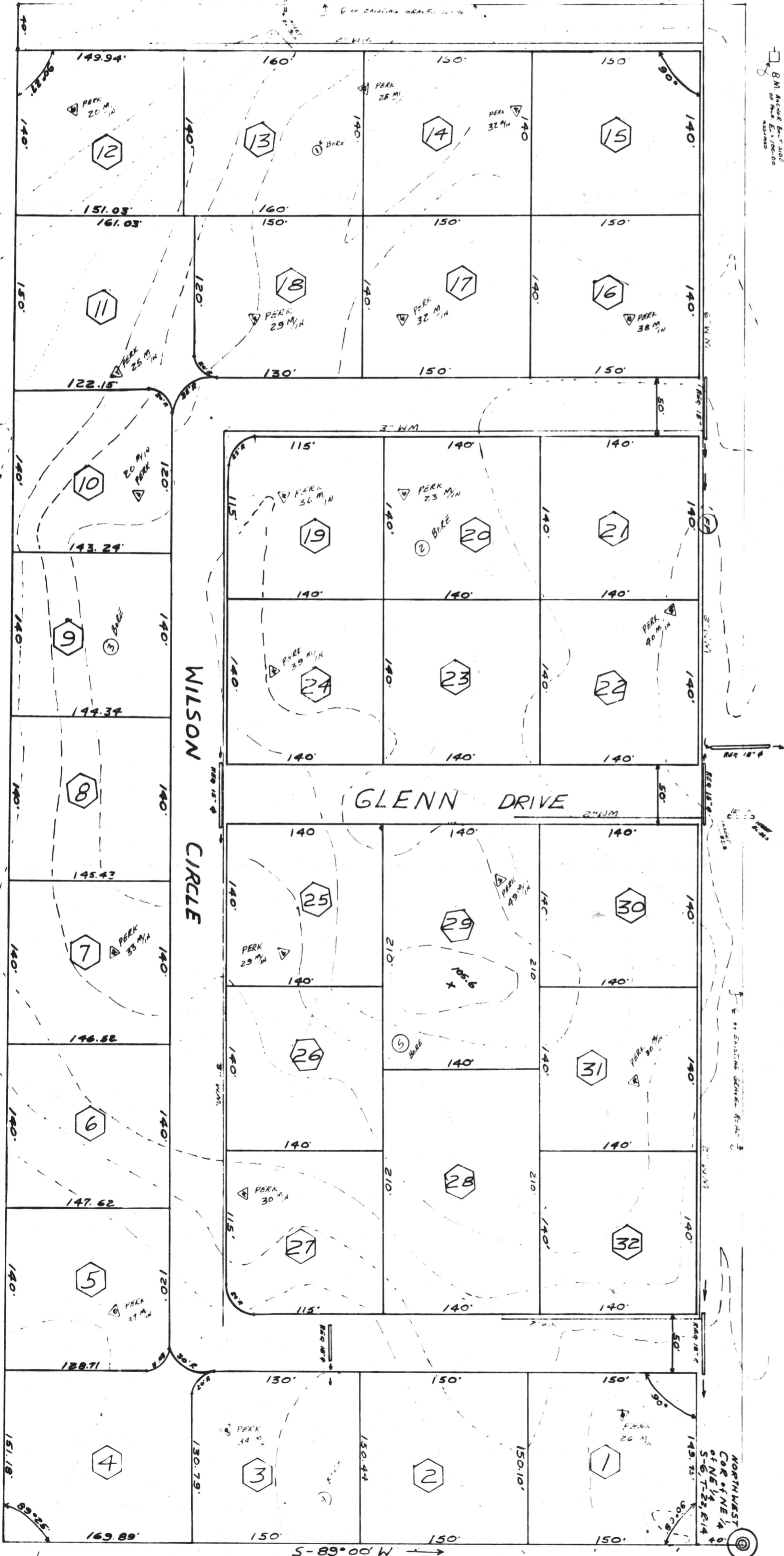
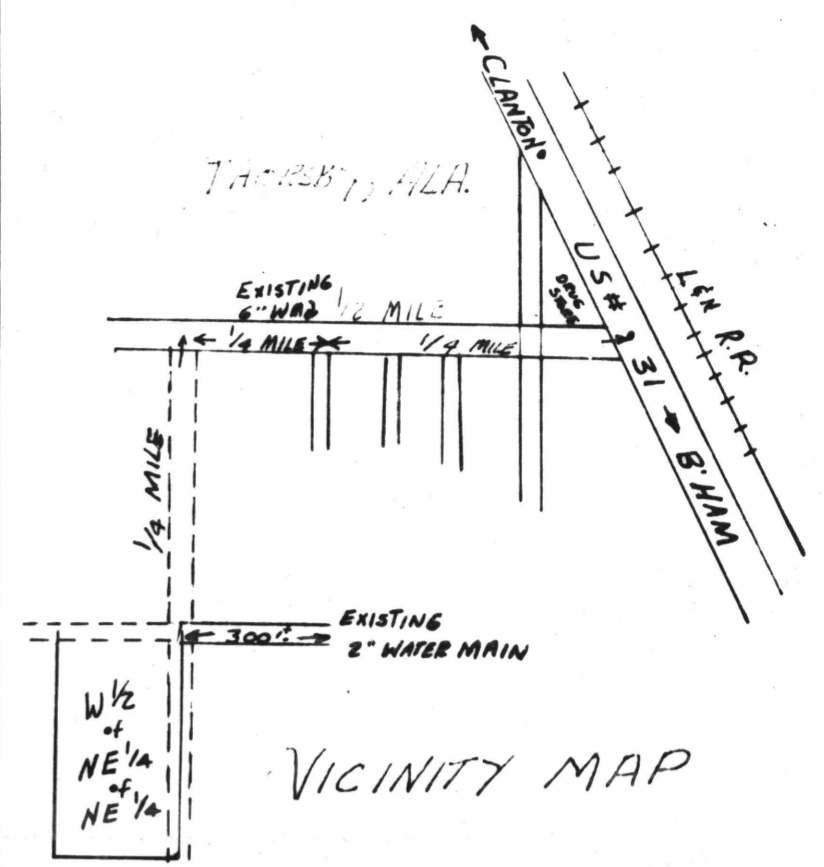


HIGH FORREST "SUB-DIVISION" THORSBY, ALABAMA
