

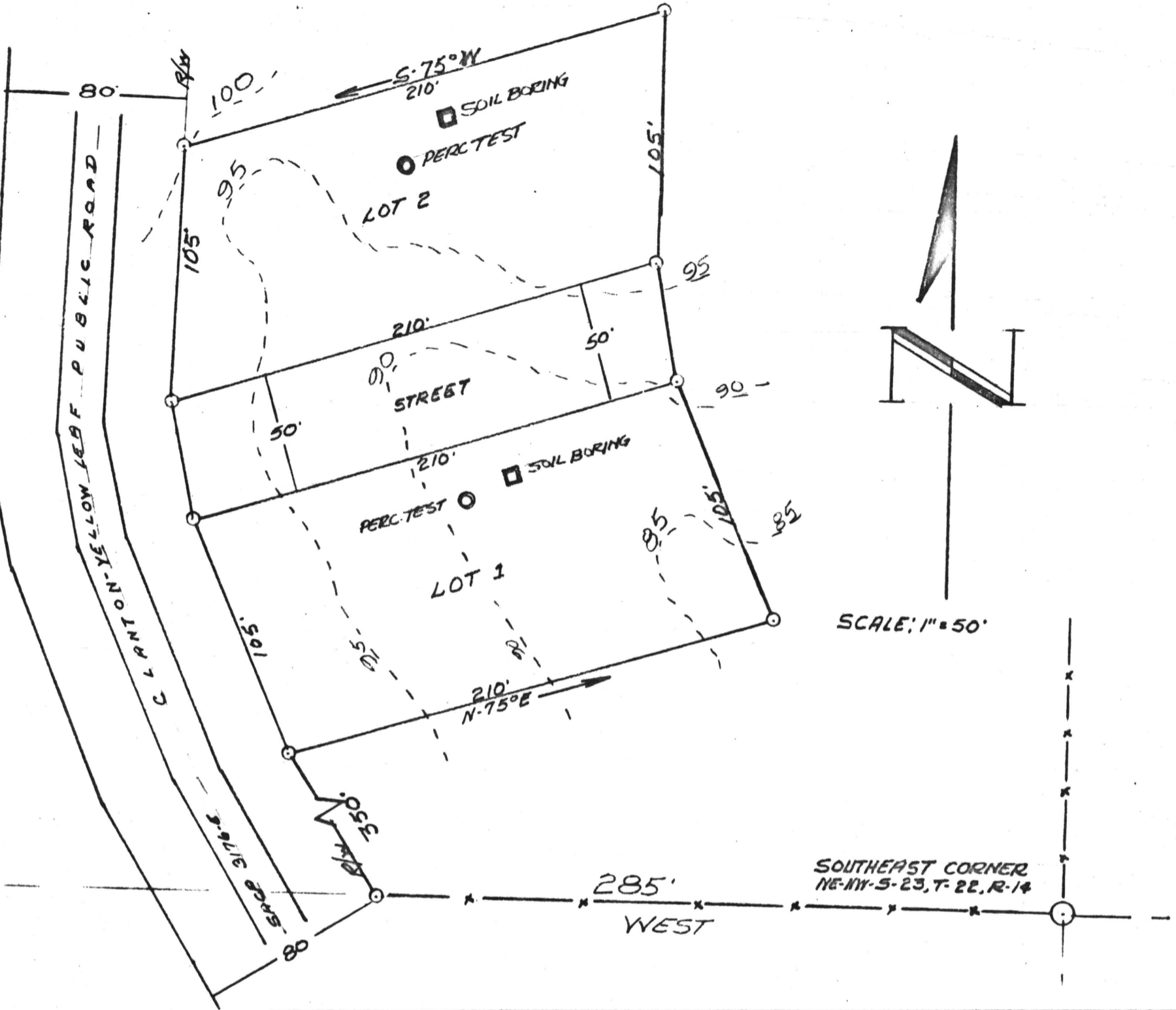
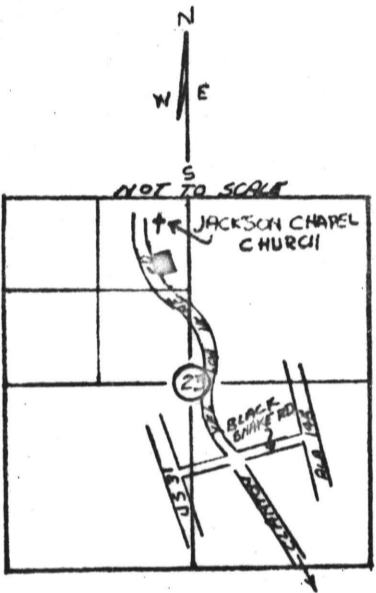

I, Harvey A. Deason, a Registered Land Surveyor, in the aforementioned State and County, hereby certify that I have surveyed the within described property of Samuel E. Burkhalter & wife Doris Burkhalter, lying and being a part of the N.E. 1/4 of the NW 1/4, S. 23, T. 22, R. 14, Chilton County, Alabama, described as follows: Start at the SE Corner of said 90 acre tract and run thence West along the South line of said 90 acre tract for 285' to a point on the east margin of SACP-3176-E (Clanton-Yellow Leaf Public Road); run thence Northwestwardly along said margin of said road for 350'; to the point of beginning of the parcel herein described; run thence N-75°E, 210' to a point; run thence Northerly and parallel to said road 260' to a point; run thence S-75°W, 210' back to said east margin of said road.
