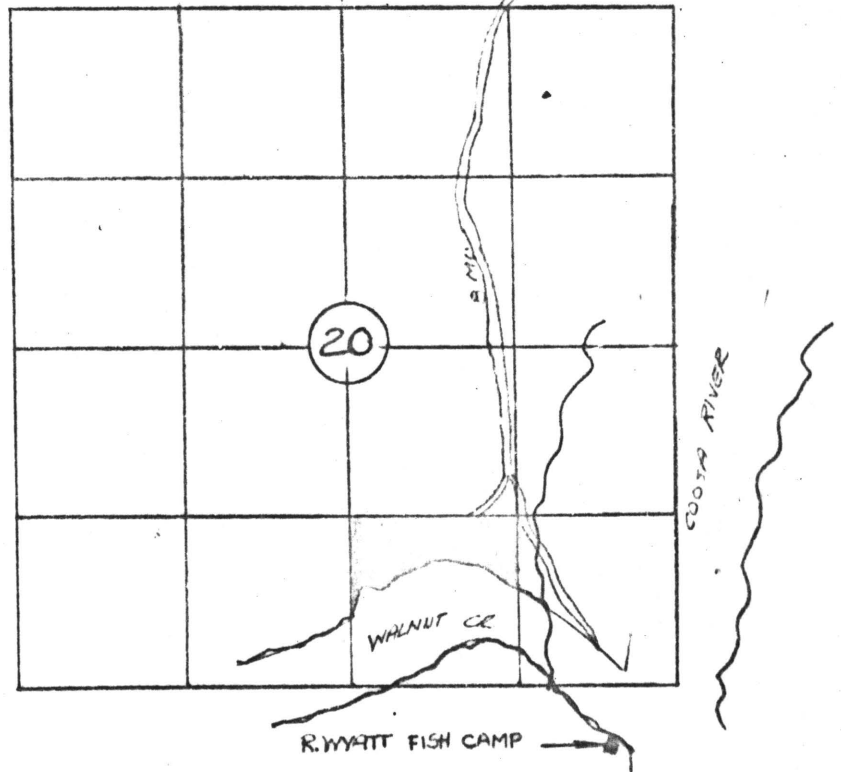


NOTE: PRESENT ROADS IN PLACE TO HAVE 10' EASEMENT ON EACH SIDE.
