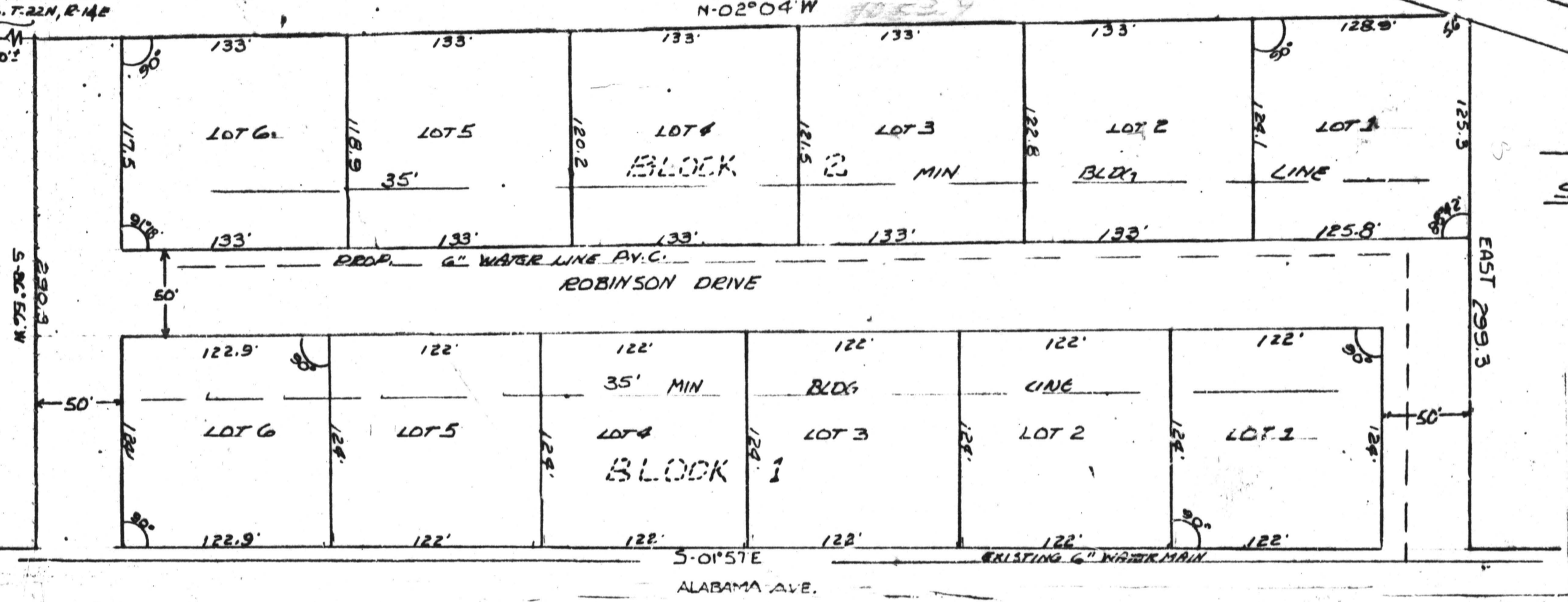


SW COR. NE-SE

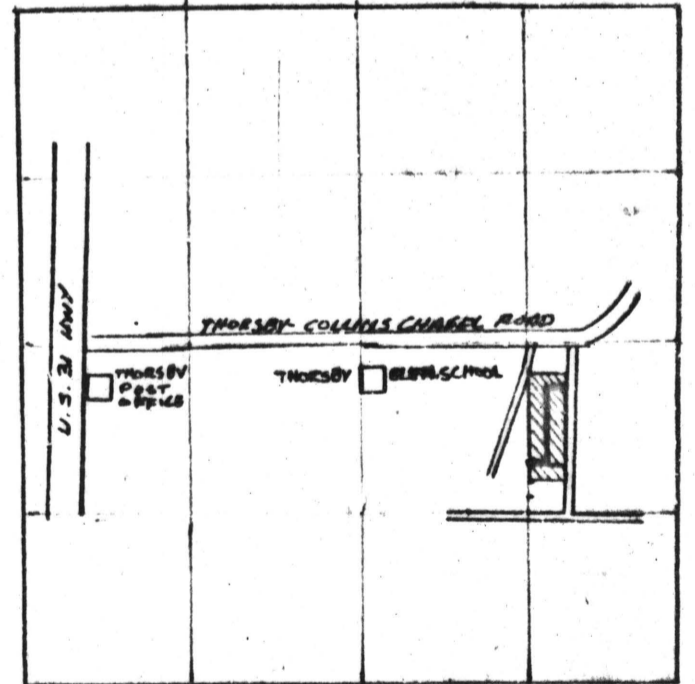
