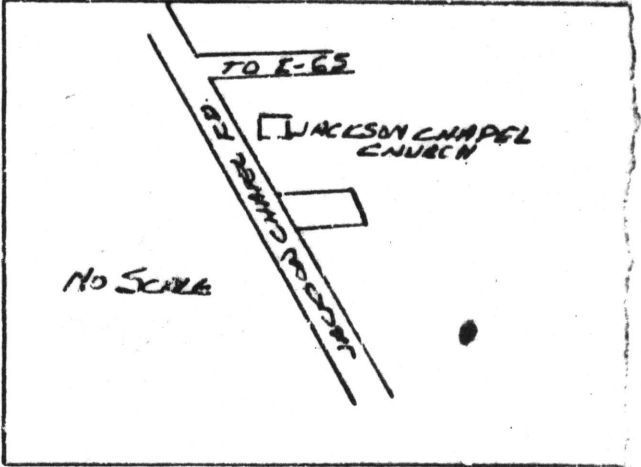


DESCRIPTION:

From the Southeast corner of the Northeast $\frac{1}{4}$ of the Northwest $\frac{1}{4}$, Section 23, Township 22-N, Range 14-E, Chilton County, Alabama, run west along the south boundary line of said NE $\frac{1}{4}$ -NW $\frac{1}{4}$, 285 feet to the east right of way line of the Jackson Chapel paved road; thence run in a northwesterly direction along the east right of way line 140 feet to the point of beginning. From the point of beginning thus established, run N-75°-E, 210 feet to a point; thence run in a northwesterly direction 105 feet to a point; thence run S-75°-W 210 feet to the east right of way line of said Jackson Chapel paved road; thence run in a southeasterly direction along the said east right of way line, 105 feet to the point of beginning, containing $\frac{1}{2}$ acre, more or less, lying east of and adjacent to the Jackson Chapel paved road, in the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$, S-23, T-22-N, R-14-E, Chilton County, Alabama.
