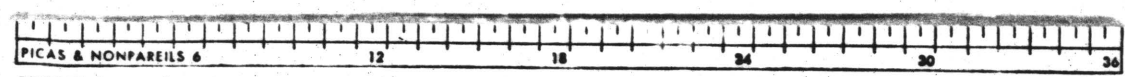
DESCRIPTION

A lot or parcel of land within the SW 1/4 of NW 1/4, Section 33, Township 23 North, Range 13 East, Chilton County, Alabama, described as follows:

Commence at the N.E. corner of SW 1/4 of NW 1/4, Section 33, Township 23 North, Range 13 East, which is the point of beginning of the parcel of land herein described and also the N.W. Corner of the Melvin C. Hartley property, thence proceed S86°08'W, along the North boundary of SW 1/4 of NW 1/4, Section 33, Township 23 North, Range 13 East (said North boundary being the South boundary of the Jim Scott property), a distance of 1321.52 feet to the N.W. corner of SW 1/4 of NW 1/4, Section 33, Township 23 North, Range 13 East; thence proceed S03°19'W along the East boundary of the Volley D. Glass property a distance of 1060.23 feet to the centerline of a County gravel road; thence proceed Easterly chords: S86°15'E - 109.61 feet; N71°28'E - 94.17 feet; N63°27.5'E - 180.00 feet; N81°09.5'E - 78.74 feet; S85°19.5'E - 96.44 feet; S79°03'E - 680.69 feet; S70°51.5'E - 81.96 feet to a point on the East boundary of SW 1/4 of NW 1/4, Section 33, Township 23 North, Range 13 East; thence proceed N01°04'W along the East boundary of said SW 1/4 of NW 1/4 (and along the West boundary of the Melvin C. Hartley property) a distance of 1170.52 feet to the point of beginning. Containing 31.65 acres more or less.
