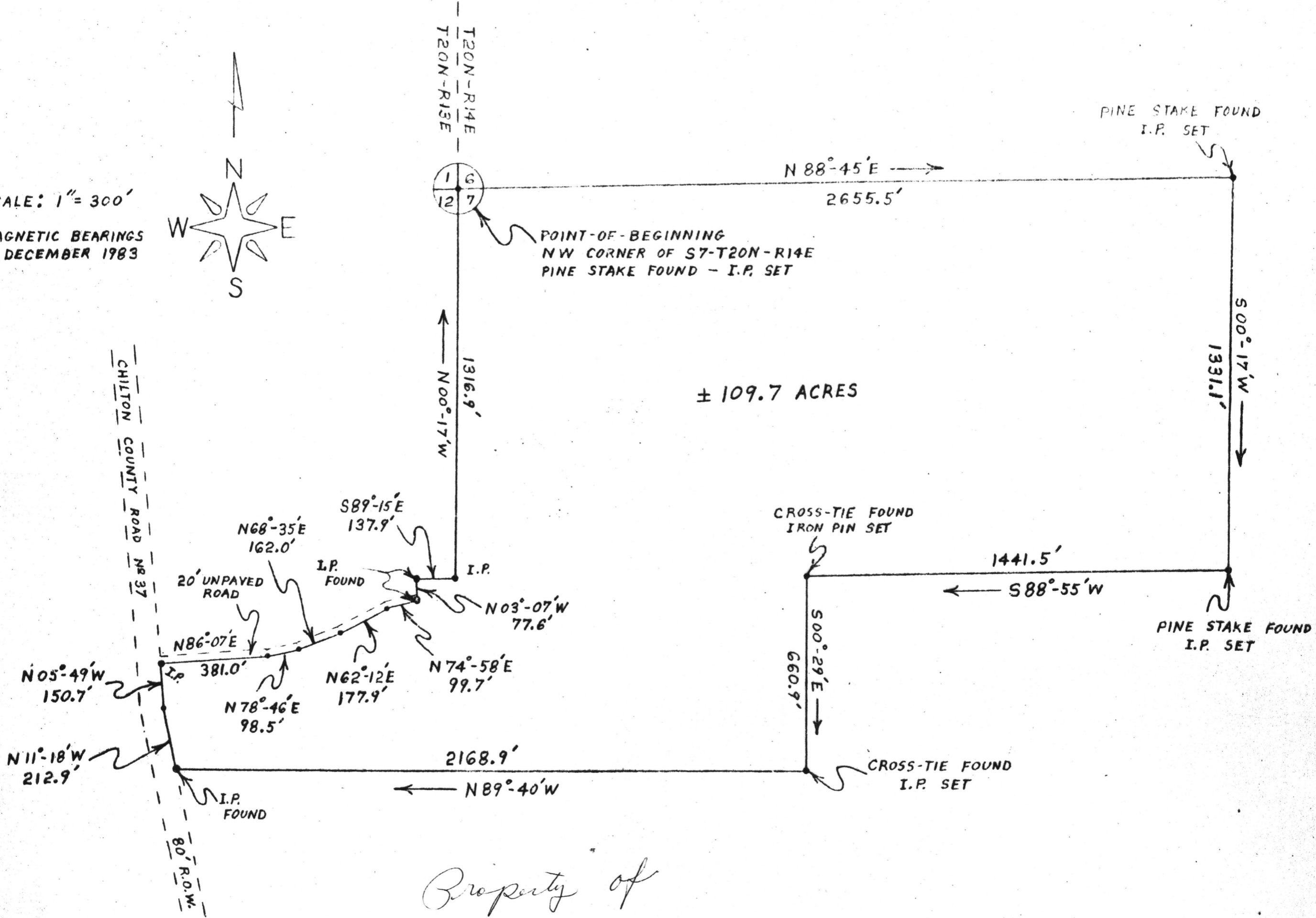
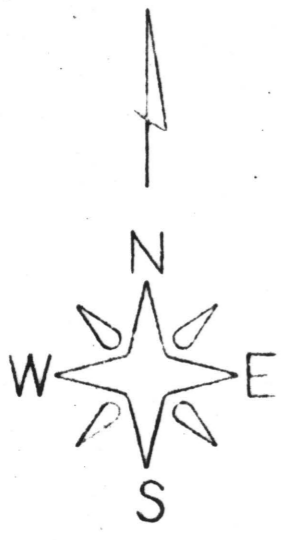

I, HORACE RAY EDWARDS, A REGISTERED PROFESSIONAL ENGINEER AND LAND SURVEYOR IN AND FOR THE ABOVE MENTIONED STATE AND COUNTY, HEREBY CERTIFY THE ABOVE TO BE A TRUE AND CORRECT MAP OR PLAT OF THE PROPERTY DESCRIBED BELOW:

A PARCEL OF LAND LOCATED IN THE N 1/2 OF THE NW 1/4 AND THE N 1/2 OF THE SW 1/4 OF THE NW 1/4 OF S7-T20N-R14E AND IN THE N 1/2 OF THE SE 1/4 OF THE NE 1/4 OF S12-T20N-R13E IN CHILTON COUNTY, ALABAMA MORE PARTICULARLY DESCRIBED AS FOLLOWS: START AT IRON PIN AT THE NORTHWEST CORNER OF S7-T20N-R14E WHICH IS THE POINT-OF-BEGINNING. FROM THE P.O.B THUS ESTABLISHED, RUN N 88°-45'E FOR A DISTANCE OF 2655.5 FEET TO IRON PIN. THENCE RUN S 00°-17'W FOR 1331.1 FEET TO IRON PIN. THENCE RUN S 88°-55'W FOR 1441.5 FEET TO IRON PIN. THENCE RUN S 00°-29'E FOR 660.9 FEET TO IRON PIN. THENCE RUN N 89°-40'W FOR 2168.9 FEET TO IRON PIN ON THE EASTERN RIGHT-OF-WAY BOUNDARY OF CHILTON COUNTY ROAD NUMBER 37, ALSO KNOWN AS THE CLANTON-BILLINGSLEY ROAD. THENCE RUN N 11°-18'W ALONG AND PARALLEL TO SAID R.O.W. FOR 212.9 FEET TO A POINT. THENCE RUN N 05°-49'W ALONG SAID EASTERN R.O.W. OF COUNTY ROAD FOR 150.7 FEET TO IRON PIN AT INTERSECTION WITH THE SOUTHERN R.O.W. BOUNDARY OF AN UNPAVED ROAD. THENCE RUN ALONG THE SOUTHERN BOUNDARY LINE OF SAID UNPAVED ROAD AS FOLLOWS; N 86°-07'E FOR 381.0 FEET TO A POINT, N 78°-46'E FOR 98.5 FEET TO A POINT, N 68°-35'E FOR 162.0' TO A POINT, N 62°-12'E FOR 177.9 FEET TO A POINT, N 74°-58'E FOR 99.7 FEET TO IRON PIN. THENCE RUN N 03°-07'W FOR 77.6 FEET TO IRON PIN. THENCE RUN S 89°-15'E FOR 137.9 FEET TO IRON PIN. THENCE RUN N 00°-17'W FOR 1316.9 FEET BACK TO THE POINT-OF-BEGINNING. THIS PARCEL OF LAND LYING AND BEING SITUATED IN THE NORTH HALF OF THE NORTHWEST QUARTER AND THE NORTH HALF OF THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 7, TOWNSHIP 20 NORTH, RANGE 14 EAST AND IN THE NORTH HALF OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 12, TOWNSHIP 20 NORTH, RANGE 13 EAST IN CHILTON COUNTY, ALABAMA; CONTAINING 109.7 ACRES, MORE OR LESS.
